Bring your registration and current plates (if applicable) to the branch at that time. Before manufacturing of these plates begins, 750 pre-orders need to be collected. Once that number is achieved, it will take approximately 6 months to manufacture the plates and for them to reach the branches.

	If you are putting your plate on a newly acquired vehicle, you must pay applicable sales tax, title and registration fees at the time of registration.
